ADVANCEMENT CRITERIA

Each association will qualify their athletes for the Regional meet, and the Regional for the National Championship meet, providing they meet all other AAU requirements.

Advancement will occur as follows:

- Competitors must advance through Association and Regional Championships to qualify for the AAU Junior Olympic Games.
- The top four (4) finishers in each age division and event advance from the Association Championships to Regional Championships.
- The top four (4) finishers in each age division and event advance from the Regional Championships to the AAU Junior Olympic Games.
- For qualification to the AAU National Club Championships, athletes must simply be registered as 2005 AAU members.

Participation of relay teams shall be limited to those clubs which hold current 2005 AAU club membership prior to the Association meet. Relay teams will consist of four (4) members plus up to four (4) alternates from the same club. All participating club members must wear jerseys and shorts of the same color at all National Championship meets. 1,2,3 placement of a relay team at the Regional meet entitles the club represented by that team to enter a relay team in the same event at the AAU National Championship. The makeup of the team need not be the same at the national level. However, the relay team members must be from the same club, age division, and gender.
